### CAL FIRE SUSPENDS BURN PERMITS

After another wet winter and above average snowpack, warming temperatures and winds are quickly drying out vegetation. The increasing fire danger posed by the high volume of dead grass and hotter, drier conditions in the region prompted CAL FIRE to suspend all burn permits for outdoor residential burning within the State Responsibility Area of Humboldt, Del Norte, and Western Trinity Counties. This suspension took effect July 31, 2023, and suspended all residential outdoor burning of landscape debris such as branches and leaves. Campfires may be permitted if the campfire is maintained in such a manner as to prevent its spread to the wildland. A campfire permit can be obtained at local fire stations or online at PreventWildfireCA.org.

## AIR, LAND, AND SEA: THE SHELTER COVE FIRE DEPARTMENT HAS YOU COVERED!



July was one of the busiest months on record for the men and women of the SCFD. Last month, the department responded to 21 emergency calls for service within 5 minutes! This resulted in one life SAVED, 10 medical patients treated and or sent to the hospital, 4 community members assisted with disabled vehicles or smoke detectors, and 7 fires either extinguished or investigated. Shelter Cove Ocean Rescue Team's new jet ski embarked on its first rescue only one month after arriving!

On July 8<sup>th</sup> Shelter Cove Fire received reports of a small plane crash in the ocean with people in the water north of the Shelter Cove Airport. Shelter Cove Fire's Duty Officer and rescue swimmer immediately responded to the scene and located wreckage and two victims in the water approximately 80 and 200 yards offshore of Little Black Sands Beach. The Shelter Cove Duty Officer gave the updated location and that one victim had made it to the beach to all incoming units before changing into a wetsuit and paddling out to the second patient. Shelter Cove Fire also launched Ocean Rescue Ski 1 & 2 along with an amphibious rescue boat. Luckily, Ski 1 and the rescue swimmer arrived at the victim just as they no longer had the ability to

swim and were able to pull the patient from the ocean and onto the rescue boat for patient assessment and safe transport back to the marina. The patient on the beach was treated for hypothermia by SCFD EMTs and transported to the airport. Both patients were flown to local hospitals in stable condition with moderate injuries. Shelter Cove Fire would like to thank all the witnesses who quickly called 911 allowing us to rescue the victims in a timely manner and to all of our emergency services partners including USCG Sector Humboldt Bay, HCSO, Reach Air Medical, Cal Fire, BLM Fire, And City Ambulance.
